## Ski Season Performance Training

Offered by FitPlan, a division of Cape Cod Rehabilitation

The Ski Season Conditioning Program is designed to help skiers achieve their maximum athletic potential while helping to reduce the risk of injury. It is an hour-long class for all abilities that will focus on the 5 aspects of conditioning (strength, endurance, power, balance and flexibility). Class will start with a 15 minute dynamic warm up, followed by a half hour of circuit training working on strength, endurance, power and balance. The class will end with a cool down period focused on increasing flexibility through ski specific stretching. The class is designed to help improve performance and potential while decreasing the risk of injury, allowing you to have more fun on the mountain this year!
